1. GENERAL TERMS AND CONDITIONS

1.2. Information on how to enter and prizes form part of these terms and conditions. By participating, entrants agree to be bound by these terms and conditions and warrant they are not prohibited from accepting a prize. Busselton reserves the right to disqualify entries for noncompliance with these terms and conditions.

2. ENTRY

2.1. Raffle ticket sales will commence on 26-Dec-2021 and will conclude on 26-Apr-2022 at 11:59 pm Australian Eastern Daylight Time or when all tickets are sold out (whichever is earlier).

2.2. There are 10,000 tickets available. Entrants are not restricted or limited to the number of raffle tickets which may be purchased.

2.3. Each single ticket is priced at AUD \$20.00.

2.4. Raffle tickets will be sold at the Busselton Jetty and online at busseltonjetty.auraffles.com.au. Employees of Nissan and Busselton Jetty Inc. and their immediate family members or any company associated with the raffle are ineligible to enter. Entrants will need to enter their personal details in the sections provided on the ticket. Incomplete or incomprehensible entries will be ineligible. Complete entries will include a first and last name, a full address and a contact telephone number and email address, at a minimum.

3. DRAW AND PRIZE
